BRIEF DESCRIPTION OF CONTENT:

Calculation of taxation payable by farmers with specific reference to:

- Farming income
- Special provisions applicable to farmers
- Stock
- Capital expenditure provisions
- Forced sale and drought relief provisions
- General rating formula for farmers
- Convergence with normal tax, VAT and Capital Gains Tax

CRITICAL OUTCOMES SUPPORTED BY SHORT LEARNING PROGRAMME:

- The ability to solve complex problems using critical and creative thinking
- The ability to critically evaluate information
