Die Minister van Justisie en Grondwetlike Ontwikkeling, mnr Enver Surty, was vol lof vir die Fakulteit Regsgeleerdheid van die Universiteit van die Vrystaat tydens die openingsfunksie van die Fakulteit se eeufees-viering vanjaar.

Die Minister van Justisie en Grondwetlike Ontwikkeling open eeufeesvieringe

Surty het ook gesê dat die Fakulteit in die toekoms 'n selfs nog groter rol kan speel in die opleiding van aspirerende regslui van beide geslagte en alle rasse om die regsberoep meer verteenwoordigend te maak.

Volgens hom het die UV die belangrikheid van gemeenskapsbetrokkenheid besef en het gewys op die belangrikheid hiervan om juriste van 'n kaliber op te lei wat die sosiale en ekonomiese toestande van ons samelewing beter verstaan.

Die Dekaan van die Fakulteit, prof. Johan Henning, sé die Fakulteit het 'n uitsonderlike geskiedenis van uitnemendheid op die gebied van teoretiese sowel as praktiese regssopleiding, wat teruggeneem kan word na die ontstaan van die Grey Universiteitskollege in 1904.

Die eerste LL.B.-grade is in 1918 toegeken aan SP le Roux, destydse Minister van Landbou en "vader" van die Fakulteit Natuur- en Landbouwetenskappe aan die UV; CR Swart, voormalige Minister van Justisie, Staatspresident en Kansellier van die UV; en W Liebenberg.

Van adv PU Fischer as die eerste genoemde dosent in die Fakulteit, tot vandag, het die Fakulteit aansienlik gegroei en is daar vandag 2700 voor- en nagraadse studente aan die Fakulteit.

Die Fakulteit is trots daarop dat van sy studente en dosente in hul loopbane voortgegaan het om van die hoogste posisies in die land te bekleë. Onder die alumni tel name van staatspresidente, ministers, administrateurs, appèlregters, regters, rektors, professore en dosente aan die UV sowel as ander universiteite, advokate, prokureurs en regadviseurs in privaatpraktyk, maar ook in diens van die regering," het prof Henning gesê.

Regter Hefer spreek studente toe

Op 4 Maart 2009 het 'n uitsonderlike geleentheid studente aan die Fakulteit Regsgeleerdheid te beurt gevall toe oud-Hoofregter Joos Hefer 'n lesing in Deliktereg by die Fakulteit aan-

gebied het. Hierdie geleentheid is gereel deur prof Rita-Mari Jansen, dosent in Deliktereg aan die Fakulteit, en maak deel uit van die Fakulteit se eeufees-viering. Regter Hefer het die stampvol ouditorium

toegespreek oor die ontwikkeling van die Deliktereg oor die afgelope 50 jaar, met 'n kritiese analise van die delikslemente. Die geleentheid is ook deur verskeie akademici en appèlregters bygewoon.

Botesverslag

'n Asseseringsverslag van die LL.B-program aan die UV is in November 2008 voltooi. Hierdie verslag spruit uit omvattende meningsopnames onder LL.B-alumni wat tussen 2000 en 2007 aan die Fakulteit Regsgeleerdheid gegradeer het.

'n Lys van alumni, wat uit 432 individue bestaan het, is vir hierdie doelendes gebruik. 'n Totaal van 156 persone het deelgeneem aan die opname wat deur 14 professionele navorsers van die Sentrum vir Ontwikkelingsteun gedoen is.

Van die hoofbevindings uit hierdie navorsing is dat byna 80% van die respondentie die Fakulteit Regsgeleerdheid as 'n eersteklas-instansie ag.

Ander bevindings wat gemaak is, is dat 7 uit elke 10 respondentie van mening is dat klasse verpligtend moet wees en 6 uit 10 het gesê dat deur dit verpligtend te maak, daar bygedra sal word tot beter voorbereiding van studente vir die regsberoep.

Die LL.B-kursus het volgens 40% van die respondentie hulle nie goed genoeg toegerus op die praktyk nie, terwyl 80% 'n hoë graad van integrasie tussen teorie en die praktyk sou wou sien. 'n Totaal van 7 uit 10 respondentie glo dat die toelatingskriteria verskerp moet word, terwyl 55% glo dat die slaag van 'n aparte toelatingseksamen in die toekoms vereis moet word.

Engels het 36% steun as verkose onderrigtaal geniet, terwyl slegs 10% van die alumni moedertaal sprekers van die

Engelse taal is. Afrikaans het 58% steun geniet, terwyl 75% van die alumni Afrikaanssprekend is. Suid-Sotho het geen steun gewerf as onderrigtaal nie.

'n Totaal van 14,6% van die respondentie het aangedui dat hulle nie weer aan die UV se Fakulteit Regsgeleerdheid sou wou studeer nie. Die redes hiervoor is fakulteitsverwant (52%), persoonlik (29%) en polities (19%). 'n Oorweldigende totaal van 80,3% is egter nie spyt dat hulle regsopleiding aan die hierdie Fakulteit ontvang het nie.

Die idee van 'n alumnivereniging word deur 60% van die respondentie gunstig oorweeg.

Possible legalisation of greyhound racing

The Department of Trade and Industry appointed a combined research team consisting of members of the Faculty of Law at the University of the Free State (UFS) and the Hotel School (CUT) to investigate the possible legalisation of greyhound racing in South Africa. The team members are prof Elizabeth Snyman-Van Deventer, dr Neels Swanepoel and adv Jaco de Bruin (all UFS) and adv Manie Moolman of the Hotel School (CUT).

The decision to ban greyhound racing in South Africa was made on the assumption that gambling at the time was immoral. The position on gambling in South Africa was since revisited. As gambling is legal in South Africa, the question has been raised whether this kind of racing is still illegal. Animal welfare and protection groups are in support of the ban on greyhound racing. The purpose of this research project is to give an objective overview of the greyhound racing industry nationally as well as internationally. This includes aspects such as animal welfare, social, economical and political issues and the legal framework pertaining to greyhound racing.

The study focuses on the current situation in South Africa and internationally regarding the jurisdictions where the sport is currently active and the legal framework in these jurisdictions. The



research project includes a comparative study of the situation in best practice countries with a focus on the USA, Ireland, the UK, Belgium, Australia, New Zealand, the Czech Republic, Sweden and Lesotho. The research team hosted 10 workshops in all nine provinces to give the public an opportunity to give inputs and share their views.

LL.M-programme in Environmental Law launched

The Department of Constitutional Law and Philosophy of Law has launched the LL.M-programme in Environmental Law for the first time in February 2009.

Environmental Law has only recently been established as a separate branch of the law, being a combination of rules taken from other branches of the law dealing with environmental aspects.

As the environment has become a burning international issue, receiving more and more attention and affecting a broader scope of society than ever before, it is currently a very important part of the modern legal agenda.

Environmental Law consists of a corpus of law which addresses environmental degradation and has an interdisciplinary

framework which draws from a range of private and public law principles.

International environmental law is one of the fastest growing fields of International Law.

The LL.M. in Environmental Law focuses on international and national environmental law, addressing the effect of the constitutional environmental clause on national environmental issues, framework legislation, environmental justice and environmental enforcement. The LL.M. dissertation in Environmental Law commenced in February 2009 whilst the structured LL.M. commences in June 2009.

2008 Aktiwiteite van die UV Regskliniek

Die UV Regskliniek op die Vista kampus is ingewy in Maart 2008, maar dit was gou duidelik dat daardie ligging ontoeganklik vir beide studente en kliënte was. Die kliniek het dus na Zastraatstraat 142 verskuif vanaf 1 Julie 2008. Die verskuiwing het onmiddellik vrugte afgewerpt in terme van toeganklikheid.

Die Departement van Justisie en Grondwetlike Sake Jeugopleidingsprogram is in 2008 voortgesit en 10 kandidaatprokureurs en 2 gekwalifiseerde regslui is aangestel. Die kliniek is besoek deur opleidingsbeamtes van die Departement asook uitvoerende bestuurslede van Aulai in Junie 2008. 'n Verslag is deur die besoekspan opgestel en weerspieël baie positief teenoorveral die opleidings- en evalueringsselsels van die kandidaat-prokureurs. Gedurende die jaar is adv Bezuidenhout en mnr Muller opgelei as assessors in terme van 'n SAQA-geakkrediteerde kursus. 10 Kandidaat-prokureurs sowel as Adv. Bezuidenhout is ook gedurende die jaar opgelei as skuldberaders in terme van die Nasionale Kredietwet.

Gedurende die oorsigperiode is aansienlike gratis regsdienste weereens deur die UV Regskliniek aan behoeftige lede van die publiek verskaf. Dit het hoofsaaklik bestaan uit gratis verdediging in strafsake in die distrikhof en 'n groot aantal egskeidings in hoofsaaklik die Vrystaatse Hoër hof. Daar is 'n totaal van 729 sake ingeneem sedert Februarie 2008 tot en met September 2008, waarvan 298 in verskillende stadia van afhandeling is. Kandidaatprokureurs aan die UV Regskliniek het ook regsdienste op deurlopende basis by the Batho Hof gelewer en ook by landdroshewe 13, 25 en 24. 200 Sake wat weens werksdruk by die plaaslike Regshulpraad nie deur laasgenoemde afgehandel kon word nie, is deur die kandidaatprokureurs afgehandel. Afgesien van die 2 deurlopende kandidaatprokureurs by die Batho Hof, is daar 'n

verdere 2 by Hof 30 op deurlopende basis geplaas. 'n Verdere 2 kandidaatprokureurs lewer op deurlopende basis 2 dae per week administratiewe bystand by die Klerk van die Hof.

Die kliniekpersoneel bestaan tans uit die direkteur, 3 gekwalifiseerde regspersaktisyns, 1 tikster en 7 kandidaatprokureurs. Agt uit die huidige twaalf van hierdie personeel bestaan uit lede vanuit die voorheen benadeelde groeperings.

Gedurende 2008 is daar 5 interaktiewe skoolpratjies by 5 verskillende skole in Bloemfontein deur vierdejaar regstudente gelewer en die vierdejaar studente het 'n lesing aan mediese studente oor die nuwe Kinderwet gelewer. Die kliniekpersoneel het ook deelgeneem aan 'n openbare inligtingsessie saam met die Departement Maatskaplike Welsyn rakende die Kinderwet. Hierna het die vierdejaar studente in gemeenskapsdiens en -diensleer insette gelewer aan die Departement vir die ontwerp van publieke inligtingspamflette.

Adv Inez Bezuidenhout en me Michelle Karels het 'n kompetisie by Dr Block, Heidedal oor maatskaplike opheffing en die voorkoming van vreemdelinghaat aangebied. Eers is daar inligtingpratjies aan leerders gelewer met betrekking tot hulle bydrae vir die voorkoming van misdaad en die voorkoming van vreemdelinghaat. 'n Kompetisie is toe aangebied waar leerlinge op uitgeknippe hande vyf voorstelle moes maak vir die bydraes wat die jeug kan lewer ten opsigte hiervan. Die samelewingsdiens- en diensleer studente moes toe die 10 beste bydraes kies en daardie leerlinge het prysie by die skool ontvang.

Twee studente, Andrea Coetzer en Stephen Meshet, het onder leiding van Adv Bezuidenhout in September aan die LexisNexis intervarsitêre simulasiehof kompetisie Universiteit Pretoria deelgeneem. Hulle het 'n oorhoofse derde plek verower uit 12 ander spanne.

Symposiums on the rights of women in Africa

Prof Charles Ngwena, W&L Law's 2008-09 Scholar-in-Residence and Professor of Health and Human Rights at the University of the Free State, chaired a symposium on April 3 2009 on the topic of exploring women's reproductive and sexual health as human rights on the African continent in the USA. Human rights scholars from around the world

gathered at Washington and Lee University School of Law for the symposium. Participants explored the implications of the Protocol to the African Charter on Human and Peoples' Rights on the Rights of Women in Africa, a human rights treaty that was adopted by the African Union in 2003 and came into force in 2005.
