#### **SHORT BIOGRAPHY**

Anthea-lee is an academic staff member at the University of the Free State (UFS) since 2017, in the Law Faculty, Private Law department. She completed her doctoral research at the University of the Free State. Her LLD thesis is titled "A critical investigation of state custodianship and its implications for the South African Property Regime". She has a solid record of engaged scholarship and postgraduate research supervision, and postgraduate module teaching. She continues to consult on security of tenure, constitutional property and land law. In addition to undergraduate and postgraduate teaching and supervision, she has experience in teaching of SLP's. Anthealee holds a Bachelors in Law degree (LLB) which she achieved in 2009 and achieved her Masters in Law degree in 2010, both degrees were awarded by the University of the Western Cape (UWC), Cape Town. The research investigates state custodianship of rural agricultural land, particularly within the context of land reform initiatives and increased regulatory controls over natural resources like water and minerals for public interest; and the efficacy of the construct of state custodianship should it be applied to land as a natural resource. In so doing, she considers the socio-political basis for the legal construct of state custodianship and whether this novel construct has yet proven capable of delivering transformative outcomes. The original contributions highlighted are the comparison of public trusteeship with state custodianship and that of rural land tenure; the implications of a state custodianship model to rural communal land tenure; and the efficacy of a state custodianship approach as a tool for transformative constitutionalism.
