Johann Neethling verwerf die LLB-graad aan die UV in 1969. In 2011 keer hy na sy alma mater terug as Senior Professor in die Departement Privaatreg. Hy is 'n voormalige Dekaan van die Fakulteit Regsgeleerdheid en Emeritus-professor van Unisa. Hy is lid van die European Group on Tort Law, 'n Navorsingsgenoot van die Europese Sentrum vir Delikte- en Versekeringsreg in Wene, Oostenryk en 'n Senior Navorsers van die Onderzoekschool *Ius Commune* in Maastricht, Nederland. Hy het 'n uitgebreide publikaserekord en was redakteur van die Tydskrif vir Hedendaagse Romeins-Hollandse Reg. In 1993 ontvang hy die Toon van den Heever-prys vir Regswetenskap van die Suid-Afrikaanse Akademie vir Wetenskap en Kuns. Hy ontvang verskeie navorsings-toekennings van Unisa en in 2008 'n B1-gradering van die NRF as 'n toonaangewende internasionale kenner in sy veld. Hy spesialiseer in deliktereg (inbegrepe persoonlikheidsreg en onregmatige mededinging).

Johann Neethling obtained the LLB degree at the UFS in 1969. In 2011 he returned to his alma mater as Senior Professor in the Department of Private Law. He is a former Dean of the Faculty of Law and Emeritus professor of Unisa. He is a member of the European Group on Tort Law, a Research Fellow of the European Centre of Tort and Insurance Law in Vienna, Austria, and a Senior Researcher of the Research School *Ius Commune* in Maastricht, the Netherlands. He has an extensive publication record and was editor of the *Journal of Contemporary Roman-Dutch Law*. In 1993 he received the Toon van den Heever Prize for juridical science from the South African Academy for Science and Art. He received several research awards at Unisa and in 2008 a B1 rating from the NRF as a leading international scholar in his field. He specialises in the law of delict (including law of personality and unlawful competition).
