

Mnr. Francois Roux (78), Junior Springbok-vleuel van 1955 en voormalige sportskrywer, is in Worcester oorlede. Hy laat sy dogter, mev. S. Rothenburg, agter.

Prof. Daan Meyer (92) is in Bloemfontein aan nierversaking oorlede. Hy was van 1977 tot 1981 hoof van die mediese fakulteit aan die UV. Hy word oorleef deur sy vrou, kinders en kleinkinders.

Mnr. Jan A. Pretorius (63), argitek van Randburg, laat sy vrou, Ria, en dogter,

Annamie, ook 'n argitek uit die Kovsies-stal, agter.

Prof. Andre du Plessis (80) van Ballito is na 'n lang siekte oorlede. Hy het die grade B.A., M.A. en die HOD aan die UV verwerf. Hy was voor sy aftrede hoof van die department sosiologie en kriminologie aan die Universiteit van Zululand.

Mnr. P.A.A. (Pieter) van Wyk (89) van Waverley, Pretoria, en voorheen hoof-instrument-ingenieur by Sasol, laat twee dogters en drie kleinkinders agter.

Lt.genl. C.M. du P. Robbertze het in 1973 sy B.A.-graad aan die UV behaal. Hy laat onder meer sy dogter Elmarie Heyns van Pretoria agter.

Ms Glaudine Audre Pittendrigh (nee Croeser) died in Vereeniging. She received a B.Sc. degree at the University College of the Orange Free State in 1946. She is survived by her husband, Dr Alan Pittendrigh, three children and two grandchildren.

Die meeste van ons is mos maar geneig om 'n tydskrif of koerant te lees, te bêre en te vergeet. Dan tydens een of ander belangrike sosiale geleentheid soos die jaarlikse lenteskoonmaak ("spring cleaning"), 'n verhuising of 'n gebrek aan leefruimte, is die opgehoopte stapel papier die eerste om totsiens te sê. Ten einde te verseker dat daar darem altyd 'n opspoorbare *Bult* in ons lewe sal wees, het ek begin om kopieë van ou *Bulte* te versamel en veilig te bewaar.

'n Paar interessante feite – die *Bult* wat jy tans lees, is die 109de uitgawe van

Bult sedert die eerste *Bult* in 1953 die lig gesien het. Sedert 1984 het dit reeds ses keer gebeur dat daar vier uitgawes van *Bult* in 'n kalenderjaar verskyn het. Die droogtejare was 1974-1975 toe net een *Bult* gedruk is. Hierdie lywige meneer hou egter die rekord as die dikste (A4) *Bult* nog, naamlik 100 bladsye. Die dunste A4-model was Desember 2001 se 20 bladsye. Die voorbladnooi is koning(in) met 33 dames wat reeds ons voorblad versier het teenoor 23 mans. Agt *Bulte* het sportlui op die

voorblad gehad en die Hoofgebou het reeds 11 verskynings gemaak.

Van die 109 *Bulte* is daar ongelukkig vier waarop ek nog nie my hand kon lê nie, naamlik die 1953-uitgawe, beide uitgawes van 1985 en die tweede uitgawe van 1990. By etlike ander is daar net een kosbare kopie beskikbaar. Ek wil 'n baie vriendelike versoek rig aan oud-Kovsies wat bereid is om enige ou *Bulte* aan ons af te staan om my asseblief te kontak. Ek is selfs bereid om dit binne Bloemfontein en die nabye omgewing te kom afhaal, sou daar 'n vervoerprobleem wees. Prof. Wynand Mouton (79), voormalige rektor van die UV, is in Junie in Rustenburg oorlede nadat sy vrou, Daleen, hom in April vanjaar ontval het. Prof. Mouton was rektor vanaf 1976-1988, Sy bande met die UV het oor 60 jaar gestrek. Voor sy aanstelling by die UV was hy die eerste viserektor van die Universiteit van Stellenbosch. Hy was voorvasser van die UV-Raad van 1991-1996 en kanselier van 1996-1999. In 1995 is 'n eredoktorsgraad deur die UV aan hom toegeken.

Prof. Teuns Verschoor, waarnemende Rektor, sê prof. Mouton het diep spore

aan die UV getrap. Hy het die UV geleei tot een van die voorste navorsingsuniversiteite in die land. Onder sy leiding is uitgebreide sportvelde op die Weskampus, en spesifiek Shimlapark, ontwikkel. Hy het toegesien dat die UV se kunsversameling groei en dat studenteproduksies in 'n moderne, goed toegeruste teater (wat later na hom genoem is) opgevoer is. "Ek is bly dat ons hom vir hierdie en ander waardevolle bydraes in 2004 met 'n Eeu feesmedalje kon vereer." Hy laat sy kinders, Wynand, Hendrik en me. Saretha Curry, sowel as drie kleinkinders agter.

The UFS has reached yet another sporting milestone – this time by sending the largest ever contingent of athletes in the history of the institution to participate in the 2008 Beijing Olympics. Five students were part of the national team that represented South Africa.

The Kovsies in the national team were Thuso Mpuang, Chris and Roelof Dednam, George du Rand and Kagiso Kumbane. Thuso Mpuang is the current 200 m champion in Africa, and Kagiso Kumbane, the reigning Africa student champion in 100 m and 200 m.

The brothers Chris and Roelof Dednam represented South Africa in badminton. Chris is the former Africa doubles and singles champion and Roelof is the former All Africa doubles champion. They are the current national badminton champions. George du Rand is the current Commonwealth 200 m backstroke record holder. He represented South Africa in the Commonwealth Games in Melbourne, Australia, in 2006.

The large contingent from the UFS is another highlight in an evergrowing list of milestones for sport at the UFS over the past few years.

Five students participated in Beijing Olympics

According to Mr James Letuka, Director of KovsieSport, the UFS rugby team (Shimlas) and the UFS netball team were crowned national champions at the 2008 University Sport of South Africa (USSA) championships. This tournament was formerly known as the South African Student Sports Union (SASSU) tournament.

The defending champions, the Shimlas, put up a splendid performance as they blasted aside Maties, Varsity College and the University of Johannesburg, among others. Waltie Vermeulen was nominated as the forward player of the tournament and, together with Wayne Stevens, Marlin Ruiters and Cameron Jacobs, was also drafted into the South African student team.

Mr Letuka says that in recent years the Shimlas won the 2007 Melrose Sevens in Scotland, the local city league in 2003, 2005 and 2006, as well as the 2004 FNB Superbowl.

Six former Shimla players, CJ van der Linde, Juan Smith, Guthro Steenkamp, Ruan Pienaar, Jannie du Plessis and Bismarck du Plessis, were members of the 2007 World Cup-winning Springbok squad. From 1912 to date the UFS has produced 62 Springboks.

The Kovsie Netball team was once again unbeaten at the 2008 USSA tournament, claiming their fourth consecutive gold. In the process they beat the Tshwane University of Technology, Tukkies, the University of Johannesburg, Maties and the Nelson Mandela Metropolitan University. Shiroleen Smith, Lienke Perold and Dirkie Schabot were included in the USSA team.

In 2006 the team won the Free State league and had 36 players drafted into the Free State teams. In the same year Karin Venter coached the Free State under-21 team to golden glory, as she did in 2007, and the current coach, Burta de Kock, coached the SA Universities team to glory in the Africa Games. She also had a stint as the national Protea coach.

In 2007, the team won the National Merit Tournament, a performance that was rewarded with the inclusion of Venter, Niemand, Elzet Engelbrecht, Anchen du Plessis, Carine Terblanche, Doretha Joubert and Maryka Holtzhausen in the national Protea team. Two Kovsies were also included in the World Cup team that was coached by De Kock.

As far as other sporting codes are concerned, Mr Letuka says the UFS cricket team won the 2003 USSA tournament, and from 2001 to 2007 represented the Free State at the Club Championships and produced seven players for the USSA team and two for the provincial team. Last year the ladies tennis team won the USSA Championship and the Free State Shield, and had two players selected for the World Student Games in Bangkok. The team followed that victory up this year by being crowned the national club champions.

As from 2009 the UFS men's hockey team, which has been campaigning in the B Section this year, will emulate its women counterparts by playing in the A Section. Bram van Wyk Snr was selected coach of the national under-17 girls' hockey team.

Athletics too is gaining ground. In the previous Olympics in Athens only one student, Johan Cronje, participated in

track and field. This year two participated in Beijing.

Last year the UFS had three Kovsies in the team that went to the All Africa Games in Algeria. This year the same number of Kovsies form part of the team for the World Junior Championships in Poland, and 12 Kovsie athletes will also go to the African Student Games in Ethiopia.

In soccer the UFS women's team was the provincial champions of the Vodacom League from 2004 to 2006 and to date has produced nine players for the USSA team.

According to the newly appointed Head of Sport Commercialisation and Strategic Development at the UFS, Mickey Gordon, who came to the UFS from the Northwest University earlier this year, the UFS has been investing substantially in student sport. These investments include the completion of two world-class astro-hockey fields to boost hockey in the Free State and the country.

In terms of the future of student sport at the UFS, Mr Gordon believes that a key focus will be on creating a more active lifestyle for students. "A broadened base of active students will maximise participation in sport. This will lead to an improved base for selection, which will increase the success rate at USSA and other levels of competition," he said.

Gordon said identifying young talent at a very early age is another key focus, together with putting in place the necessary support systems and resources. This will help to attract the best sportsmen and sportswomen to the UFS and raise the level of sport performance at the UFS to even greater heights.

'Let's take our

Extracts from speeches by Dr Franklin Sonn, Chancellor of the University of the Free State, at the graduation ceremonies in April this year.

South Africa has a wonderful future ahead of it. There is absolutely no doubt about that. Often we get a little depressed or we get dismayed by the degree of the challenges that face us. And we often lose sight of the fact that these are typically transitional problems.

In a country like this in transition, in a transforming society, people haven't internalised fully the burdens of freedom.

I refer particularly to freedom as a burden, because it is also a joy. The burden is that it places an enormous sense of responsibility on any young person or on any citizen to conduct himself with such decorum that he acts within the law. The law is two sided, it is factual, but the law is also an assumed state of how a citizen conducts himself, a citizen that limits his own conduct, that can discern between right and wrong. It is a process and it will take us a long time before we all understand the responsibility of citizenship.

I lived for a while in the United States of America and what strikes me in that democracy, because it's an older democracy, is how the citizens themselves uphold the law, protect the law, and protect their own rights and those of others. The law-enforcement officers merely supervise the activity, but the imposition of conduct within the law is the responsibility of every citizen. Every

overstepping of the law is considered not breaking the law as it is considered in our country still. It is considered a social outrage.

There is no possibility that people will go beyond the speed limit. They observe the speed limit, partly because they fear that if they overstep it would be an outrage against society. You can't, like we do, sit at a dinner party and tell friends that you were caught speeding, because their response would be: "How could you? You mustn't do things like that." Here, if we tell people that you have driven far too fast and that's why you are here early, they will say: "Great". There the approach is: "You have broken the law."

In deep democracies people don't do that. People defend the rights of orderly living circumscribed by the law. But the law is not the imposition; the imposition is the conduct, the interaction between the citizenry. In South Africa we have a long way to go. There is still an underlying perception that if you can get away with it, you are a hero. Nobody is a hero who breaks the law. And I want to commend to you that you take this to heart and that you take this along with you with your qualification.

Attendant to that is also the issue of social conduct. We as a university conduct ourselves within the confines of what we consider as an institution, as a university. And a university has a very special place in society. We conduct ourselves along the lines that we consider to be proper

conduct, to be civilized conduct. Civilized conduct is something which you bring to a university and the university merely enforces it. It's a fundamental duty of the schools, of the churches, but more specially of the parents to ensure that when a student enters university he / she can discern between right and wrong, that he / she can discern what is in good taste and what is in bad taste and that he / she conducts him- / herself in the manner which does him-/herself proud, does the parents proud, town proud, but also in the end makes the university proud.

There is still conduct which society at large finds and experiences as an outrage. And here I'm not specifically referring to the University of the Free State. I'm referring to all universities. If we fail at university level to make our students understand their responsibility, to act with proper decorum, to observe their actions, to consider the impact and the effect of what they do to others, I think society at large has the right to look doubtful at the quality of our education.

Often universities like to boast about standards of excellence, and quality education. But I would suggest that if the quality of education that we refer to only refers to the academic standards that we maintain, it's a skew approach to the matter. It refers to the extent to which the academics in their classes spend 5 minutes twice a day, twice a week just stepping aside and ensuring that our students know how

to handle the degree that they in time will receive at a ceremony like this.

We cannot be blasé about this, we cannot blame the administration, we cannot blame the students, we as academics have a bounden duty to observe wrong when it's wrong, to see right and endorse it when it's right.

Students, look at yourself in the mirror and ask yourself: are you going to take society a bit further, a bit higher, so that we as a nation can aspire to a democracy which is not essentially governed by laws, merely circumscribed by laws, but a society which is directed by good and sound social conduct. This is what the University of Free State stands for. I think you are all aware that, people and particularly the media, tried to depict the University of the Free State as this backward institution

where the students and the academic staff, all of us (the Chancellor as well) don't know right from wrong.

We know that is not the case and wherever I go, I make a point of that. I tell them of the facts, my experiences of you, and I tell them what we really are. I also told them that anywhere in the world, without in any way diminishing the extent of the outrages that students commit, but just to gain perspective, to understand, that across the world, at Harvard University, at Oxford University, at all universities in the world, students are students.

I often used to say to my students, a student is not a human being. And then they act with outrage: "What do you mean?" And I say no, a student is a student, and if they are still outraged, I say,

no they're a higher species than human beings, but they're essentially students.

What I mean by that is to say: enjoy your youth, make use of every minute to enjoy your youth, live it to the full, but remember you owe it to yourself, owe it to your family, you owe it to the brand that you now carry wherever you go, you carry the brand of the University of the Free State. It's on you certificate, it's on your degree and wherever you go, people will ask you: where did you qualify. Protect that brand and in the main, help us as a nation to get to a point where merely the touching of somebody's property will be an outrage. Not an outrage which you call the police for, but an outrage that you as a citizen will protect, so that we can live a life of wellbeing.

Probably the most difficult task that awaits you students, is to go into life and mitigate the tension between good and evil, between fallacy and truth, and to find the way where I am proud of the fact that I am woman, but I will consider man equal to me in every way. That I'm proud that I'm South African, but I will consider New Zealand as equal in every way, that I'm proud that I'm black, but I will consider white to be equal to me in every way, and that our differences are infinitesimal in relation to our similarities.

Education means leading the world, leading other people to find this comfort and to find this unity. It does not mean that we must deny our differences. Differences, identity, are something to be celebrated. Our unity, our sense of humanism, our sense of who we are as one nation, is of the greatest importance.

UFS rector steps down

At its meeting in September the UFS Council expressed its heartfelt thanks and appreciation to Prof. Frederick Fourie, Rector and Vice-Chancellor, for his contribution to building and developing the university. Prof. Fourie announced that he will step down from his position in the last quarter of this year.

His association with the university stretches over a period of 40 years: from student, lecturer, dean, vice-rector and finally as rector and vice-chancellor.

In his announcement Prof. Fourie said: "Obviously this decision has not been taken lightly. After careful consideration I am, however, convinced that this is as far as I can take the UFS as vice-chancellor and rector. This flows primarily from the exhausting times that I have experienced during the past nine years, first as vice-rector (since 1999) and then as rector (since 2003), in managing and implementing several complex strategic projects.

"The challenges and complexities of continuous change management at a higher education institution, and specifically the demands of further dynamic development and transformation at the UFS, demand enormous amounts of emotional energy and drive. For me the stress due to, especially, the political divisions and tensions in the UFS Council and the broader university community during the past year has been extremely draining. The broader institution and its people also show signs of trauma."

Judge Faan Hancke, Chairman of the UFS Council, said in a statement when the university was operating at a loss during 2000 and it was in a financial crisis, Prof. Fourie came up with a financial turnaround strategy which took the UFS out of this crisis to a position where it can annually spend considerable amounts on strategic projects. This led to large amounts being invested in the academia and especially research. As a result, the UFS's research capacity and research equipment has been expanded. Since 2003 research output increased with about 50%,

which is a great achievement for the UFS's researchers and its faculties.

Judge Hancke said progress was also made with diversity, the UFS's balanced multilingualism policy in the academia as well as administration, employment equity, the Transformation Plan and the Institutional Charter. Under Prof. Fourie's leadership there was an upgrading and extension of the infrastructure, academic buildings and facilities as well as support services and student facilities.

"Prof. Fourie has an excellent intellect and exceptional abilities which can still make

a huge contribution to the improvement of the South African society."

Herman opgewonde oor toekoms

nMens is nooit te oud om te leer nie, en ander persone is nooit te jonk, onervare of ongeleerd om van te leer nie.” So sê prof. Herman van Schalkwyk, Dekaan van die Fakulteit Natuur- en Landbouwetenskappe, wat vir ’n verdere termyn van vyf jaar aangestel is.

Hy is sedert 2003 aan die stuur by die fakulteit. Onder sy leierskap het die fakulteit reeds talle hoogtepunte bereik en gegroei tot ’n invloedryke instelling, bekend vir wêreldklas- akademiese gehalte, navorsing en die suksesvolle voorbereiding van studente vir hul loopbane in die wetenskap. Hy is besonder trots op die sukses oor die afgelope paar jaar en skryf die prestasies daarvan toe dat mense alleenlik presteer wanneer hul gelukkig is en wanneer daar ’n omgewing geskep is wat prestasie aanmoedig. “ ’n Dekaan behaal slegs sukses deur die mense in sy fakulteit.”

Sy entoesiasme oor die fakulteit is duidelik sigbaar. Volgens hom heers daar ’n kultuur van betrokkenheid, produktiwiteit en prestasie. “Kyk maar na rugbyspanne. Wanneer daar nie ’n goeie gees is nie, verloor hulle sommer. Hierdie fakulteit het gees!”

Dit is vir hom lekker om deel te wees van ’n wenspan wat saamgestel is uit doense wat nie net nasionaal nie, maar ook internasionaal erken word vir hul bydraes tot hul onderskeie vakgebiede. Hy beskou dit as ’n belangrikeoorweging wanneer ’n mens moet kies waar jy wil studeer. Daarom is sy boodskap: “Daar is géén plasvervanger vir uitnemendheid nie.”

Voordat hy as dekaan aangestel is, was hy voorsitter van die Departement Landbou-ekonomiese aan die UV. Hy dien ook op die dagbestuur van die UV se Uitvoerende Bestuur en is die voorsitter van die Dekanekomitee. Benewens sy werk by die UV, is hy betrokke by talle provinsiale en nasionale instansies. Hy is onder meer in 2007 in die Nasionale Landboubemarkingsraad aangestel en in 2008 as die voorsitter van die Raad van Landbank. Hy is ook ’n konsultant vir die Wêreldbank en vir ander Suid-Afrikaanse instansies, ’n spesialis in landbou- en landbouverwante hofsake en ’n gereeld spreker by landbouverenigings in Suid-Afrika en Namibië, om slegs ’n paar te noem.

Alhoewel Johannesburg sy geboortestad is, is die Vrystaatse grond bekend onder sy skoene. Hy het in Warden grootgevorm en was in 2006 ’n finalist vir die Bloemfonteiner van die Jaar-toekenning. Hy is ’n deeltydse veeboer wat probeer om ten minste elke Saterdag saam met sy gesin op die plaas te kom. “Dit neem my gedagtes weg van alles en plaas my in ’n situasie waar ek elke Maandag weer vars voel om die nuwe uitdagings te aanvaar.”

Uitdagings is daar beslis. Die fakulteit het volgens hom ’n belangrike rol om te speel. “Hoë voedselprysse, voedselkwaliteit, aardverwarming, die gehalte van ons water, bewaring van ons biodiversiteit, infrastruktuur wat energie bespaar en oliepryse is alles aspekte wat die rustige bestaan van die wêreld se bevolking uitdaag en / of bedreig. Die wetenskappe wat deur die fakulteit bedryf word, kan ’n baie groot bydrae lewer om antwoorde vir dié uitdagings te vind.”

Hy sal graag wil sien dat die fakulteit sy internationale rol nog verder uitbrei en dat nog meer samewerking, uitsluoreenkomsse en vennootskappe ontwikkel word. “Ons studente moet nog meer die gevoel kry dat hulle blootgestel word aan die beste van die wêreld.”

Prof. Van Schalkwyk glo nie aan gemaksones nie en beskou verandering as die enigste konstante. “Jy kan kies of jy weerstand teen verandering wil bied, of jy dit

wil ignoreer en of jy deel van die verandering wil wees en dit wil beïnvloed. Om dit reg te kan beïnvloed en vir ons nageslag ’n goeie toekoms na te laat, moet ons verandering in die regte rigting stuur. Dit vereis dat ons ingeligte besluite moet neem, betrokke moet wees en hard moet werk.”

Hy glo Suid-Afrika bied baie geleenthede in hierdie verband en die UV kan ’n leiersrol hierin speel. Siende dat universiteite die leiers van mōre oplei, kan dit ’n groot impak op die land se toekoms hê. “Ons het ons te midde van al die negatiewe publisiteit vanjaar verbind om jongmense toe te rus om die uitdagings van ’n diverse bevolking te kan hanteer. Om ’n Kovsie te wees, beteken dus dat jy nie net jouself kan toerus om ’n betrokke lid van die gemeenskap te wees nie, maar ook dat jy in hierdie mikrokosmos kan deel wees van positiewe verandering vir ’n beter toekoms.”

Hy gaan homself daarop toespits om die fakulteit nog beter te posisioneer as ’n betrokke, nasional- en internasional-erken-de instelling. “Die personeel en studente kan almal hiervan deel wees en hulself uitleef in die visie. Dit maak ’n mens sommer lekker opgewonde oor die toekoms!”

UFS researchers honoured

Researchers at the University of the Free State received two prestigious awards from the National Science and Technology Forum (NSTF) during its tenth gala-awards ceremony held in Kempton Park.

The NSTF awards give recognition to the outstanding contributions of individuals and groups to science, engineering and technology. This includes all practicing scientists, engineers and technologists across the system of innovation, including, for example, teachers and students in mathematics, science and technology. The NSTF represents government, science councils, professional bodies, higher education, business and civil society.

Prof. Maryke Labuschagne from the Department of Plant Sciences was the female recipient of the research capacity-development award over the last ten years for her successful mentoring of black researchers and students. The award includes

a prize of R100 000 which will be used for research purposes.

Prof. Labuschagne, an expert in the field of plant breeding and food security in Africa, received the award for her contribution to the training and development of black students and researchers in this field. Various black students successfully completed their postgraduate studies under her guidance at the UFS during the past ten years. Research by her South African students has led to a firm research relationship between the Agricultural Research Council (ARC) and the UFS, while research by her local and international students has culminated in no less than 82 publications over the last decade.

It has also led to the establishment of collaboration agreements with universities and research institutes in Malawi, Kenya, Uganda and Tanzania. Among these are the agreement with the University of Malawi where Prof. Labuschagne and her students

are involved in the International Programme in the Chemical Sciences (IPICS) of the Uppsala University in Sweden. The project focuses on the study of genetics and chemistry of tropical roots and tuber crops in Malawi. This has led to collaboration with international research organisations and has generated overseas funding.

A team consisting of Prof. Jan van der Westhuizen and Dr Susan Bonnet from the Department of Chemistry and Prof. Kenneth Swart and Prof. Thinus van der Merwe from Farmovs-Parexel received the innovation award for outstanding contribution to science, engineering and technology from an individual or a team over the last ten years. They won an award for the synthesis of drug analogues used as reference products in the analysis of the drug concentration in blood from existing and new drugs registered nationally and internationally.

The project resulted in capacity building in synthetic organic chemistry, mass spectrometry and chromatography. Five master's degrees were completed, seven are in progress, and six postgraduate students commenced with Ph.D.'s. The skills transferred during this project are already being applied to examine the properties of indigenous medicinal plants as part of the recently established UFS novel drugs and bio-active compound cluster.

Applied Biosystems, the Canadian manufacturer of mass spectrometers, donated equipment of R10 million for this project. As a result the UFS is one of the few universities in the world that can offer postgraduate training in bio-analytical chemistry.

Prof. Hendrik Swart, Head of the Department of Physics, and Dr Martin Ntwaeborwa, senior lecturer at the department were finalists in the research-capacity developer and black-researcher categories respectively.

Nine individuals and three organisations were presented with the NSTF Awards trophy by the Minister of Science and Technology, Mr Mosibudi Mangena.

Agriculture can help fight poverty

Since the early 1960s Africa has gone from being a net exporter to a net importer of food. Per-capita food production has declined as the 2% annual increase in food production could not keep up with the population growth rate of 3%. Africa is the only place in the world where overall food security and livelihoods are deteriorating.

Over the past 15 years the number of Africans living below the poverty line (\$1/day) has increased by 50 %, and it is estimated that one-third of the continent's population suffers from hunger. Around 70% of Africans are working in the agricultural sector, therefore through dramatic improvements to agriculture, prosperity can replace poverty.

In India, much of Asia and Latin America, a Green Revolution that began more than a generation ago relied on high-yielding crop varieties. It more than doubled agricultural production, saved many lives, and laid the foundation for the economic progress seen there today.

A green revolution for Africa is possible, as proposed by the Alliance for a Green Revolution in Africa (AGRA) funded by the Bill and Melinda Gates Foundation. This agricultural revolution must rely on uniquely African solutions to uniquely African problems: solutions that improve the productivity, biodiversity, and nutritional quality of food crops.

An important AGRA initiative is the development of new crop varieties that will withstand pests and disease, cope with drought, marginal soils and other environmental stresses, and dramatically increase farmers' yields. This will be done by trained plant breeders.

Good education is a prerequisite for sustained agricultural production and economic development. There is a direct correlation between economic development in countries and the number of students enrolled in higher education.

In Africa financial constraints in terms of university education are severe and demand for higher education has never been greater. There is also a need to enroll more women, although the Food and Agriculture Organisation of the United Nations (FAO) reports that the enrolment of women has increased from 15% to nearly 25% of total agriculture students in Africa. Education outside the continent has been seen as a way to fill the manpower gap, but this has often proved to be inappropriate to the unique development needs of African students.

Training in Africa has many advantages above overseas training. Course work is geared toward African needs and students in African M.Sc. and Ph.D. programmes are more likely to focus their research on local and national problems than students in overseas universities.

The UFS experience

The division of Plant Breeding has been training M.Sc. and Ph.D. students from all over Africa since the early 1990s. From 1990, 50 M.Sc. and 35 Ph.D. students completed their degrees. Students who are enrolled or have completed their degrees, represent 13 African countries.

Researched crops include the major food crops such as maize, wheat and cassava. Other crops include coffee, linseed, canola, sorghum, sunflower, sugarcane, sweet potato, pepper and cotton. Research fields include molecular (marker assisted

breeding and biodiversity studies), biochemical (quality of crops for human and industrial uses), and conventional (breeding for adaptability, biotic stress, disease and insect resistance etc.).

Students have been funded by various organisations such as the World Bank, the Rockefeller Foundation, International Maize and Wheat Improvement Center (CIMMYT), International Crops Research Institute for the Semi-Arid Tropics (ICRISAT), International Institute for Tropical Research (IITA), governmental grants and others. The training has been as beneficial for the UFS and for the students, as it has lead to collaborative research. It has also created the opportunity to study biodiversity in crops indigenous to Africa. Many of our former students are heading research programmes, are directors of research or are consulting for ministers of agriculture.

The future

There are many opportunities for collaborative research and training of students from African countries. We should take hands in Africa and work towards a greater goal of food security. From the side of the UFS we can do it by training postgraduate students who can go and make a difference on the continent.

Genadedood meer aanvaarbaar onder sekere groepe

Medici is oor die algemeen ten gunste van genadedood. Daar is egter faktore wat 'n belangrike rol speel by die bepaling van hul houding teenoor genadedood.

Daar is bevind dat ras 'n sterk determinant van medici se houdings teenoor genadedood is. Die swart rassegroep is die sterkste aanduiding van 'n negatiewe houding teenoor genadedood, terwyl die wit rassegroep weer 'n sterk determinante is van 'n positiewe houding teenoor genadedood. Dit beteken dat swart medici sterk gekant is teenoor genadedood en dat wit medici goedgesind is daarteenoor.

Spesialisering is ook 'n sterk bepalende faktor ten opsigte van houding teenoor genadedood. Spesialiste en chirurge is beduidend meer positief teenoor genadedood as algemene praktisyns.

Geloof is nog 'n belangrike bepalende faktor. Die ongelowige groep (ateïste en agnostici) is die positiefste teenoor genadedood en die nie-Christen-groep (Moslem- en Hindoe-gelowe) die negatiefste teenoor genadedood. Die evangelies-Christen-groep (Gereformeerde kerk, Nederduitse Gereformeerde kerk, ens.) is meer gekant teenoor genadedood as die ongelowige groep, maar meer positief daarteenoor as die nie-Christen-groep.

Daar is laastens gevind dat chirurge wat tussen 11 en 15 jaar lank al praktiseer, 'n beduidend groter aanvaarding toon

van genadedood as die ander groepe medici in dieselfde praktykstermyne. Altesaam 217 medici by private hospitale in die Vrystaat het aan die ondersoek deelgeneem. Sekere faktore wat medici se houdings teenoor genadedood beïnvloed, is geïdentifiseer, naamlik rassegroep, geslag, ouderdom, spesialiteitsrigting, aantal jare in die praktyk en geloof. Hierdie faktore is ook in die betrokke studie ondersoek.

Die studie kon egter nie aantoon dat daar beduidende verskille voorkom ten opsigte van geslag en ouderdom by medici se houdings teenoor genadedood nie.

Aangesien medici se houdings teenoor genadedood en hulle gedrag daarteenoor in 'n mate konsekwent is, beteken dit dat indien genadedood in Suid-Afrika gewettig sou word, die moontlikheid bestaan dat sommige van die medici genadedood sal toedien aan pasiënte wat dit versoek.

Die doel van die studie was om medici vanuit verskillende rassegroepse houdings teenoor genadedood te ondersoek. Genadedood word al vanaf antieke tye uitgevoer en gedebatteer en is wettig in lande soos Nederland, België, Switserland en die staat Oregon in die VSA.

Aktiewe genadedood behels dat 'n aktie uitgevoer moet word ('n middel word deur 'n medikus toegedien) wat die dood van 'n pasiënt tot gevolg het. Passiewe genadedood behels die weerhouding of opskorting van aktie wat die pasiënt se lewe sal verleng of die mislukking om op te tree om die pasiënt se lewe te verleng.

Vrywillige genadedood is wanneer die pasiënt toestemming gee of self vra dat genadedood op hom of haar toegepas word. Nie-vrywillige genadedood vind plaas wanneer die betrokke pasiënt nie toestemming kan gee vir die toediening van die genadedood nie, omdat hy of sy nie oor die vermoë beskik om toestemming te kan gee nie en ander persone dit in sy of haar beste belang ag om op die tydstip te sterf.

Medikus-geassisteerde selfmoord is die toediening, voorskryf of voor-siening van medikasie deur 'n medikus, op die eksplisiële versoek van die pasiënt, sodat hy of sy, sy of haar eie lewe daarmee kan beëindig. So is morfien byvoorbeeld 'n pynstiller, maar dit is ook 'n respiratoriese depressant wat kan lei tot longontsteking, hipoventilasie of apnee, wat uiteindelik die pasiënt se dood kan veroorsaak. In Suid-Afrika mag medici tens passiewe genadedood toepas, maar aktiewe genadedood is steeds teen die wet.

Voorstanders van genadedood gebruik argumente soos die kwaliteit van die pasiënt se lewe, die beginsel van selfbeskikking, sekere mediese argumente en genade-argumente, terwyl die teenstanders argumente soos die verskuwingssargument, minagting vir die heiligheid van mense se lewens, die bedreiging van individuele outonomie en vele ander argumente gebruik.

Sisulu calls for Mugabe to go

Human rights activist and renowned author Ms Elinor Sisulu has called on the president of Zimbabwe, Robert Mugabe, to step down.

Ms Sisulu made this call in August during her presentation of the Women's Day lecture: "Voiceless and voiceless, fleeing zanophobia into xenophobia: A Zimbabwean woman's perspective of National Women's Day". The lecture was presented on the Bloemfontein Campus of the University of the Free State.

She said thousands of Zimbabweans who fled their country because of violence will not return home unless Mugabe steps down.

"For the Zimbabweans in diaspora, what Mugabe symbolises is so powerful that as long as he is there as a ceremonial president they will not return home. So the simple message from the South African office of the Crisis in Zimbabwe Coalition is that Mugabe must go," she said.

She also lambasted the southern African region generally, and South Africa in particular, for its silence over what she calls "Zanu-PF orchestrated violence" that triggered the refugee influx in the region.

"The South African government was totally silent on the loss of life of innocent and vulnerable Zimbabweans. The mediator said nothing about it," she said in a clear reference

to president Thabo Mbeki, mediator appointed by the Southern African Development Community (SADC).

She said for the Zimbabweans who had to flee to South Africa it was a case of "jumping from the frying pan into the fire", fleeing Zanu-phobia to xenophobia.

She, however, appealed to the South Africans to raise their voices about the refugee problem that is not only besetting this country, but the whole region.

Ms Sisulu was born in Zimbabwe and works in the South African office for the Crisis in Zimbabwe Coalition, the major umbrella body of Zimbabwean non-governmental organisations.

Reitz se deure sluit

Studente het die geleentheid gehad om tot die einde van Julie aan te bly sodat hulle die tweede eksamengeleenthed kon aflê.

Reitz-kamerwonings was aan die begin van die jaar in die nuus oor 'n video waarin vier vroulike kollegas en 'n man van 'n skoonmaakmaatskappy aan 'n "kamma"-inisiasie-seremonie in die koshuis deelgeneem het. Die video het nasional en internasional opslae gemaak.

Die UV-bestuur het die video in die sterkeste terme veroordeel en gesê dit is 'n geïsoleerde manifestasie van weerstand teen die deurlopende transformasie-inisiatiewe van die UV. Die video het die universiteit se

reputasie nasional en internasional geskaad. Prof. Teuns Verschoor, waarnemende Rektor, het gesê: "Die UV-bestuur het daarom besluit dat die sluiting van die Reitz-kamerwonings 'n onvermydelike strategiese noodsaklikheid is en 'n belangrike gebaar van versoening teenoor alle Suid-Afrikaners wat te na gekom is."

UFS is eager to face Consultants appointed to assist

Three agencies have been contracted to support the UFS management and make recommendations on how to accelerate transformation and reposition the institution as an academically excellent and socially engaged university.

Prof. Teuns Verschoor, acting Rector, said the three agencies each have expertise and experience in their chosen field and are meant to work together as a team of consultants and work together with management. "We have all been through a difficult time. Now we need to think clearly and act decisively so as to move beyond our difficulties. The agencies must help us to think clearly and act in the best interests of the UFS."

These agencies are BGIM (to provide issue and reputation management support); thinking fusion

(to develop a brand-marketing-communication strategy to reposition the UFS in the higher education landscape); and iGubu (to assist with the successful implementation of diversity policy in student residences). The agencies will work together to co-ordinate their work to avoid duplication and maximise the effectiveness of their work. They will provide each other with input and insights gained through their work and co-ordinate their various output responsibility.

Their services are interrelated and all have a role to play in helping the university with its transformation process. Their roles are aligned with the 2007-2010 UFS Transformation Plan.

The transformation challenges that they will have to assist with, are:

- Create and maintain a sense of belonging among all staff and students

by transforming the institutional culture to one that fosters, nurtures and celebrates diversity.

- Enhance and foster diversity in student and staff life as a strength of the UFS.
- Establish the UFS as an engaged and responsive institution of higher learning and as a university of excellence.
- Ensure alignment of vision and mission in governance and management alignment in realising vision and mission.

BGIM is led by former journalist Brian Gibson, who established issue management as a specialist discipline in South Africa in 1984. BGIM has successfully managed a wide range of complex issues relating to asbestos and health, sugar and health, transformation of the Western Cape Health Department and a wide range of issues for clients such as Eskom, Sasol, and Rio Tinto, amongst others.

Institute will help to combat discrimination

In an endeavour to make restitution and to offer a lasting contribution to transformation at the UFS and in South Africa, the UFS has committed itself to establishing an Institute for Diversity on the premises of the former Reitz Residence, Prof. Teuns Verschoor, acting Rector, said at a press conference where the closure of the Reitz Residence was announced.

The Institute for Diversity is envisaged as a centre of academic excellence for studying transformation and diversity in society – a living laboratory for combating

discrimination and enabling and enhancing reconciliation in societies grappling with the issues of racism, sexism and xenophobia.

Prof. Verschoor said that in responding to the challenge faced by the UFS regarding its own transformation issues, as well as those faced by the country, the UFS will study the anti-transformational impulses on the campus as a microcosm of much broader socio-political challenges. The UFS will transform itself over time into a beacon of hope, combating racism and other forms of discrimination in South Africa and elsewhere in the world.

The Institute for Diversity will add impetus to the UFS's existing transformation programme. Six strategic clusters, including a transformation cluster, were created in 2007 as part of the long-term strategic planning.

The UFS has already provided seed capital of R1 million to design and establish the institute. Planning will take place during 2008 and 2009 and the institute will be opened in the 2010 academic year. An international fund-raising drive will be launched.

difficult challenges ahead

BGIM will be responsible for providing issue and reputation management support to the UFS management that will require strategic interventions in response to dynamic developing issues. They will be providing management support for the overall co-ordination and integration of the work of the three agencies. The objective of the co-ordination and integration support is to ensure that these services are aligned with these strategic interventions.

Thinking fusion is led by co-owners and directors Dr Rene Uys and Harry van der Merwe. Dr Uys has extensive experience in the higher education sector as an academic, researcher and marketing and communications professional, as well as private-sector experience. Mr van der Merwe has extensive experience in the private sector, particularly HR management. He has worked throughout Africa, as well as in Australia, the UK, the USA, the Middle East and Western Europe. He is a specialist in the facilitation of complex

strategic issues with executive teams and large groups.

Thinking fusion will be responsible for a long-term brand-marketing-communication strategy and the development of a three-year implementation plan. The main purpose of this project is to reposition the UFS within the South African higher education landscape. In the short term they will address the repositioning and communication challenges posed by the transformation process, including marketing and communication support for student recruitment. Thinking fusion will also be responsible for collating and integrating all desk and original research in respect of stakeholder attitudes and beliefs on behalf of the three agencies.

iGubu is led by its CEO Rudi Buys, who has been involved in youth leadership development for a number of years, including at higher education institutions in the Western Cape. The agency specialises in

mentoring individuals and teams and in facilitating the participation of communities in transformation and reconciliation initiatives in specifically an African context, and does so from a leadership development perspective. They have extensive experience in facilitating programmes for diversity and integration.

iGubu will assist with understanding and identifying current obstacles to the implementation of the residence integration policy in the residences on the Main Campus in Bloemfontein. This agency will also formulate and help implement proposals to enhance and successfully implement the policy. In their research they will talk to students and other role players regarding ways of building unity on campus. After that the kind of programmes that may be implemented to further integration in residences will be determined together with stakeholders and the most suitable ones will be implemented.

UFS awards shield of honour





UFS acclaimed for research on Khoe-San languages



Research by the University of the Free State to document Khoekhoe and San languages in South Africa thought to be extinct, was acclaimed at a Khoekhoe and San Languages Convention on the Main Campus in Bloemfontein earlier this year. The emphasis of the convention was on language revitalization and research in South Africa with the Khoekhoe and San culture, identity and memory as sub-themes.

Music, song, poetry and dance performed by people from the Khoekhoe and San communities formed part of the convention which was held over three days. Speakers were, among others, from universities in South Africa, Namibia and Botswana, the Max Planck Institute in Leipzig, the Pan South African Language Board, the National Khoekhoe and San Language Board and the Commission for Protection and Promotion of the Rights of Cultural, Religious and Linguistic Communities. The keynote address was by Adv. Sonwabile Mancotywa, CEO of the National Heritage Council.

The Unit for Khoekhoe and San Studies at the UFS organised the convention to raise awareness about Khoekhoe and San languages still spoken in South Africa and to develop a better understanding about their nature. It also sought to promote research into Khoekhoe and San languages and support for the teaching and learning of these languages.

Menán du Plessis, a post-graduate student of the University of Cape Town, said the Korana dialect of the Khoekhoe language was until very recently believed to be extinct. Seventy years ago researchers warned that the study of the nearly extinct Korana dialect is most urgent, while the few old speakers of

it are still alive. "Lately, however, a few speakers have been discovered who quite astonishingly – indeed heroically – still recall fragments of Korana. Dr Mike Besten and colleagues of his at the University of the Free State are currently working with these speakers to document as much as they can of this rare and remarkable material."

Du Plessis said: "With the admirable exception of projects currently being undertaken by historians and other scholars at the University of the Free State – in partnership with the University of Tromsø, Norway – the work of documenting our own region's most highly endangered languages is being conducted by foreign linguists. Academics based in departments of linguistics and African languages at South Africa's own universities are making almost no effort either to assist directly, or to provide courses that would enable a new generation of graduates to start participating."

American and German researchers also found a few elderly people speaking other varieties thought to be extinct. Vigorous efforts are underway to document these languages.

Concern was expressed at the convention for the lack on government side to advance the Khoekhoe and San languages. Nama, the most established of the Khoekhoe and San languages, still needs to be recognised as an official language.

Dr Andy Chebanne of the University of Botswana emphasized the importance of preservation of the Khoekhoe and San lifestyle. He said younger Khoekhoe and San people have no knowledge of

Prayer in Khoekhoe one of the oldest

The text of the Lord's Prayer in the Cape Khoekhoe language (Adolf-Kalden, c.1696) is one of the three oldest text records of any indigenous South African language, and has therefore a place of incalculable significance in the cultural history of South Africa, Menán du Plessis, post-graduate student at the University of Cape Town, said at the Kho-San Languages Convention in Bloemfontein.

The Lord's Prayer in 17th Century Cape Khoekhoe:

t̄l sa di kamink ouna...
Hem kouqueent see,
dani hingua t̄sa inhee k'chou ki,
quiquo t̄l hommingā.

Tire cita k̄l chōá t̄l authummá -
k'hamta cita hi aquei hee k̄l dou auna.

food plants and skills to quench their thirst. Their hunting skills are quickly lost. "They lost their vital knowledge of medicinal plants; and with all the lost skills and knowledge they quickly lost their culture and their important linguistic vocabulary repertoire. The reason for this tragic loss is that the Kho-San are made to live outside their land which attaches them to biological and socio-historical experiences of their existence. For a human being it is a tragedy to lose one's identity – culture and language and land. The experience of this loss is like death and the most excruciating pain is to live with a dead identity."

Dr Besten, an organiser of the convention and lecturer in the UFS Depart-

ment of Anthropology, said the convention enabled the few and isolated South African workers in this field to interact. It also provided ideal opportunities for the fostering of increased transfrontier co-operation with academics from countries such as Namibia and Botswana. A heartening aspect was also the eloquently clear message received from various high-level official quarters that academic attention to issues surrounding KhoeSan culture and language is now recognised as a serious priority, and that such work is likely to receive strong administrative support.

He also said a degree of clarity was obtained concerning the kind of linguistic interventions that are not merely needed, but likely to be feasible:

- The introduction of mother-tongue early learning for children in communities where Nama, Khwe or !Xun are actually spoken. The practical details remain to be worked out.
- Acceleration and intensification of efforts already underway to document those KhoeSan languages now spoken by only a few elders.
- Possible revival of !Ora (Koranataal). "One of the most extraordinary moments of the convention was when Ouma Jacoba McLaire delivered an entire address in !Ora – confounding those delegates who had up until then supposed that the last surviving speakers of this once major language of the old Cape now recall only a few isolated words of it," he said.

Landbou-opleidingsprogrammaak geskiedenis

UFS gets R3,6 million to train court interpreters

A contract of R3,6 million has been awarded to the UFS to train court interpreters throughout South Africa. The contract was awarded to the Department of Afroasiatic Studies, Sign Language and Language Practice by the Safety and Security Sector Education and Training Authority (SASSETA).

Prof. Annelie Lotriet of the Department of Afroasiatic Studies, Sign Language and Language Practice said: "We are the only tertiary institution in the country that offers a national diploma in court interpreting. It provides a unique opportunity to court interpreters to be trained by lecturers who are experts in the field." Prof. Lotriet is an internationally renowned interpreting expert who was also responsible for the training of interpreters for the former Truth and Reconciliation Commission.

According to Prof. Lotriet no co-ordinated training programmes for court interpreters existed and there was also no control over the training processes. "It is the first time that the Department of Justice and Constitutional Development initiates such an extensive training programme for court interpreters," she says. The group of 100 court interpreters on the programme are from all over the country.

The programme stretches over two years and comprises of theoretical and service training.

DiMTEC received a learnership to the value of R5,7 million for the master's degree programme in Disaster Management for 2008 and 2009. The learnership programme is funded by the national Department of Science and Technology with DiMTEC as the implementing agent. The learnership makes provision for the study costs and an allowance for 15 students in 2008 and 20 students in 2009. Students are placed at disaster management centres and departments who deal with disaster management across the country where they obtain in-service training on how to effectively deal with disasters. This is the only learnership of its kind in the country.

The National Control Laboratory (NCL) for Biological Products in the Faculty of Health Sciences at the UFS celebrated its tenth year of existence. The NCL does quality control of all human vaccines in South Africa. Chemie se fasiliteite is van wêreldklas

Die Departement Chemie het die eerste en tweede fases van die suidelike vleuel van die Moerdyk-en Anneksgebou waarin die departement gehuisves word, in gebruik geneem. Die vleuel is deel van die grootskaalse opgradering wat aan die gebou en fasiliteite gedoen word.

Die totale opgraderingskoste van R40 miljoen aan die gebou en R30 miljoen vir toerusting is die grootste projek van hierdie aard in die geskiedenis van die UV. Die opgradering vind in vier fases plaas en die grootste gedeelte van die suidelike vleuel, wat uit die eerste- en tweedejaar-laboratoriums bestaan, is deur navorsers en voorgraadse studente betrek.

Die laboratoriums bestaan uit onder meer groter en veiliger ontlugting, navorsingsgefokusde fasiliteite en genoegsame stoorpole vir toerusting.

Prof. André Roodt, hoof van die departement, sê die totale opgraderingsprojek sal na verwagting aan die einde van 2009 voltooi wees en die UV sal dan met van die beste navorsings- en voorgraadse laboratoriums in die land kan spog. Dit sal ook die UV se posisie in gevorderde opleiding in Afrika verhoog en sy rol in die internasionale chemie-arena versterk.



The prize money of R50 000 will firstly be used to pay recipients' academic fees at their respective academic institutions and thereafter it can be used for research, a study tour or any other expenditure relevant to academic assignments.

A central selection panel consisting of well-respected architects, architectural academics and the Fuchs Foundation made the selection.

For Charles, being chosen to represent the UFS was already a great honour and an achievement of which he is very proud, especially in view of the fact that only one student from every university is chosen to take part in the competition. “For me, the best part of the competition was working with students from other universities and to see their work. Each university has its own architectural niche, and being exposed to other ideas was an incredibly enriching experience.”

As far as the prize money goes, Charles hopes to do a bit of travelling to other parts of the world to study different architectural designs. “I find the study of world architecture fascinating. Hopefully I will bring many new experiences and ways of doing back to South Africa, thereby contributing to our very own architectural landscape.”

The criteria for the awarding of the prize included prior academic performance, covering the three years of the BAS-degree programme, a portfolio submission representative of all three years of the Architecture course, work done in professional architectural offices, as well travel experiences / research during the “year out” and 24-hour design task (based on a specific brief) presented to the selection panel as part of the selection process and an interview by the panel.


