

## **FREQUENTLY ASKED QUESTIONS**

### **(Solomon Mahlangu Scholarship Fund 2017)**

**1. What is the difference between a Bursary and a Scholarship?**

A scholarship is a financial award granted to a student on the basis of the student's academic or sporting excellence. A Bursary is a financial award granted to a student on the basis of the student's financial neediness. For the Solomon Mahlangu Scholarship Fund, the student has to produce proof that his/ her parent(s) or guardian(s) are not in a position to afford paying for tertiary education (earn under R15 000 household income per month).

**2. How many people will benefit from the scholarship?**

A total of about 150 students will benefit from the scholarship starting in 2017. About 300 students from previous intakes are still on the scholarship.

**3. How do I submit my application?**

You can submit your application online via the NYDA website or send a printed completed form to the address given in 'applications'. **NO** faxing or direct submissions to universities or NYDA offices.

**4. Can I submit my application form at an NYDA branch as it is closest to where I stay?**

No. You can either apply online or send your manual form to the address provided.

**5. Can I use my mid-year Grade 12 or Grade 11 results to apply for scholarship fund?**

Yes, but you will also have to attach or send your matric certificate once you receive it.

**6. Will the funding from the scholarship also assist me with my registration fee that is required at the beginning of the academic year?**

No.

**7. Why is the academic achievement set at 70% average?**

A scholarship is awarded on the basis of academic excellence. Most funders will require an average of 80% or more however the NYDA is a youth development agency, it is targeting youth who have potential who are from previously disadvantaged backgrounds.

**8. Does the scholarship roll over (automatically renews itself) for the duration of my studies?**

The scholarship is awarded for the duration of your studies. However NYDA will only renew the scholarship if the student has passed all of his/ her major subjects.

**9. What are the conditions for me to retain my scholarship once it has been awarded to me?**

- To observe and comply with all relevant and applicable regulations of the tertiary Institution,
- To pass all of your major subjects,
- Not to alter any of the subjects taken in the applicable diploma/degree or change to another diploma/degree,
- In the event that the student is offered any other form of financial assistance (a scholarship, bursary, grant, loan, or merit award for exceptional academic achievement, excluding pocket money, during the year of study for which the scholarship was awarded), the student must notify the NYDA accordingly,
- Sign a contract with NYDA, stipulating the terms and conditions.

**10. If NYDA has funded my first year in 2015 and I have passed all my subjects, what happens to the subsequent years?**

The scholarship is awarded for the duration of study. If you pass all your subjects each year the scholarship will be renewed.

**11. Will the scholarship fund also give me a monthly allowance/stipend for the duration of my funding period?**

No. The Solomon Mahlangu Scholarship Fund covers books, food, tuition fee and accommodation but offers no stipends.

**12. If I decide to change my degree in the middle of the year will I lose the scholarship?**

Yes. You are not allowed to alter or change the degree/ diploma once the scholarship has been awarded.

**13. I am in my second/third year of studies with the NYDA bursary, can I still apply for the scholarship for next year?**

No. The scholarship is awarded to students who started their first year of study

**14. I am already studying at university doing a course which is not on the list of courses funded by NYDA. If I change to those that are being funded by the NYDA and start my first year in that course next year, will my application be considered?**

Yes.

**15. I am currently studying at a private institution doing a UNISA degree, will my application be considered**

No. The scholarship will approve students who intend to study at public South African universities and universities of technology

**16. If I am funded through the scholarship for my studies and then I fail one subject, what happens then?**

It will depend on whether the failed subject is a major subject or a minor subject. The following conditions will apply to failing of subjects:

- If you fail one minor subject and the university allows you to progress to the next year or next semester but requires you to repeat the failed subject. The scholarship will continue however it will not pay for that repeated subject.
- If you fail one major subject and the university *does not* allow you to progress to the next year or next semester the scholarship will be terminated

**17. If I fail my studies for whatever reason, will I then be required to pay back NYDA or will they repossess my parent's house?**

No.

**18. My sibling and I are currently in matric, we both intend to pursue further education in the coming year. Is there a limit on how many people can be funded from the same family?**

No.

**19. Applications to TVET Colleges were previously accepted, what about this year?**

TVET College studies are no longer considered for the Solomon Mahlangu Scholarship Fund: only South African public Universities and Universities of Technology.

## 1. BACKGROUND

- 1.1. The Department of Higher Education and Training published a *List of Occupations in High Demand: 2014* in *Government Gazette Vol. 593 No. 38174*, in November 2014<sup>1</sup>.
- 1.2. This gazette (2015) is an update of the 2014 *List of Occupations in High Demand*. It retains the occupations listed in 2014, but reorganises and extends the list, based on the application of new information and an improved methodology.
- 1.3. The list is considerably longer than the 2014 version since it records all occupations at the 6-digit code of the Organising Framework for Occupations (OFO), as opposed to having some occupations clustered, as was the case in the 2014 version. Furthermore, new occupations were added to the 2014 list, based on new information and an improved methodology.

## 2. PURPOSE

- 2.1. The primary purpose of the *List of Occupations in High Demand* is to support the planning processes of the Department of Higher Education and Training with respect to the post-school education and training system, particularly in relation to enrolment planning, resource allocations, career advice and qualifications development.
- 2.2. Universities, Colleges, education and training providers, employer bodies, employers, professional bodies, trade unions and other organisations are also expected to use the list to support their own decision-making processes.
- 2.3. The need to identify skills needs is part of a process of developing a post-school education and training system that is responsive to the needs of individual citizens, communities and the economy, as well as in meeting the broader social developmental objectives<sup>2</sup> of the country.
- 2.4. Information about occupations in high demand provides useful insights into the skills needs of the economy and mismatches between qualifications and occupations – a problem that is particularly important to address, given that the South African labour market is characterised by high unemployment on the one hand, and skills shortages, on the other.

### 3. LIFESPAN OF LIST

- 3.1. The *List of Occupations in High Demand* will be reviewed every 2 years, unless it is deemed necessary to do so earlier. The next *List of Occupations in High Demand* is planned to be published in 2017.

### 4. MEANING OF OCCUPATIONS IN HIGH DEMAND

- 4.1. There is no single, universally accepted definition of “*Occupations in High Demand*”. For the purpose of this gazette, the following definition has been formulated:

***Occupations in High Demand refer to those occupations that show relatively strong employment growth, or are experiencing shortages in the labour market.***

- 4.2. More specifically, occupations are said to be in high demand if they:

- have shown relatively strong employment growth over the past 5 years;
- are currently showing relatively strong employment growth (that is, relatively strong growth over the past two years);
- are expected to show relatively strong employment growth in the future;
- have been identified as being in shortage<sup>3</sup> in the labour market; or
- are and new and expected to emerge in the near future as a result of innovation, technological advancements and the development of new industries (for example, the establishment of new occupations in “green” industries).

- 4.3. The above definition of the term “*Occupations in High Demand*” encompasses the idea of occupational growth (past and future), occupational shortages, and new or emerging occupations.

### 5. RESEARCH METHODS

- 5.1. A number of research methods were used to update the 2014 *List of Occupations in High Demand*. This included:

**Data Analysis:** Data from the Quarterly Labour Force Surveys provided by Statistics South Africa, and the Job Opportunities Index compiled by the Department of Labour

were analysed to determine occupational growth and job vacancy trends, respectively.

**Econometric Modelling:** The Linked Macro-Education Model, which forecasts occupational growth trends until 2025, provided information on the top 20 fastest growing occupations and the top 20 occupations with the most number of job openings for the next 10 years.

**Literature Review:** Publications that focus on issues pertaining to skills supply and demand, and the imbalances between these, at both national as well as sectoral levels, were reviewed.

**Stakeholder Engagement:** Interviews with stakeholder representatives, a workshop with skills development experts, and a “Call for Evidence” were used to obtain first-hand information on occupational trends.

## 6. CRITERIA USED TO IDENTIFY OCCUPATIONS IN HIGH DEMAND: 2015

6.1. The following criteria have been used to determine whether a particular occupation should be included in the *List of Occupations in High Demand: 2015*.

6.2. Occupations that meet any one of the above criteria were eligible for inclusion in the *List of Occupations in High Demand: 2015*.

## 7. CALL FOR EVIDENCE

7.1. The DHET compiled a *Draft List of Occupations in High Demand (2015)*, and issued a *Call for Evidence* to its stakeholders to review the draft list in order to improve its validity.

7.2. This *Call for Evidence* invited stakeholders to propose:

- the **inclusion** of occupations in high demand, with supporting evidence;
- the **exclusion** of occupations, with supporting evidence, and
- **new occupations** that are emerging, or are expected to emerge in the future, as a result of factors such as technological advancements, innovation and the establishment of new companies, with supporting evidence.

7.3. Stakeholders were invited to respond to the *Call for Evidence* by submitting the following information to the DHET:

- the name of the occupation proposed for inclusion or exclusion;
- the applicable occupational code for the identified occupation (except in cases where no occupational code exists), and
- evidence for the inclusion or exclusion of the identified occupation (make reference to, or cite the source of evidence or information).

7.4. The *Call for Evidence* generated 37 submissions from various organisations. Generally, respondents requested the inclusion of additional occupations in the list.

7.5. The Department received responses from the public categorised as follows:
